MINUTES OCTOBER 16, 2025

A regular meeting of the Board of Members of Rapidan Service Authority was held on October 16, 2025, at the Madison County Administration Building, Madison, VA.

A quorum was present and the meeting was called to order at 2:00 p.m., followed by the Pledge of Allegiance.

Present: Members: Coppage, Davies, Johnson, Marshall (2:06 p.m.)

Staff: G.M. Clemons, D.O. Jarrell, D.A. Gaskins

Attorney: Stefan Calos (via Zoom)

After moving item 6H of the agenda to the position of 6D and renumbering the other items appropriately, the agenda for the meeting was adopted on a motion by Coppage, seconded by Davies, and passed on a unanimous voice vote.

The minutes of the September 18, 2025 meeting were amended to include the following sentence after the end of the next to last paragraph: **See attached motion and certification.** The minutes were then approved on a motion by Coppage, seconded by Davies, and passed unanimously on a voice vote.

There was no old business or public comment. There were no customer requests. During the opportunity for Board comment, Mr. Coppage reiterated his opinion that the hiring of a PIO would be beneficial to RSA and the public.

On a motion by Davies, seconded by Coppage, at 2:03 p.m. the Board unanimously voted to go into a closed session as permitted by the Code of Virginia for consultation with legal counsel regarding specific legal matters related to RSA policy. Upon leaving the session at 2:13 p.m., Board members individually certified that only permissible topics had been discussed during the session. See attached motion and certification.

The Board then considered adopting a proposed RSA policy regarding signage. There were a couple typos and punctuation errors in the draft which will be corrected and an additional item which Mr. Calos will add regarding proper maintenance requirements. On a motion by Coppage, seconded by Davies, the Board unanimously voted on a voice vote to adopt the proposed policy with the inclusion of the additional language regarding maintenance requirements.

On a motion by Coppage, seconded by Davies and subject to the signage policy just adopted, the Board voted to approve the American Legion's request to erect a sign on RSA property in Madison on a unanimous voice vote.

G.M. Clemons then gave his report. Overall, RSA is in good shape financially and there is nothing out of the norm on the financial report. Mr. Davies asked if there was a chance of making up the current budget deficit in the final quarter, and G.M. Clemons indicated that it was possible but not likely. The wet summer caused anticipated water sales to be down a good deal, but RSA is still in good shape.

MINUTES OCTOBER 16, 2025

Attorney Calos then gave his report. Based on contact from the claims administrator, he is hopeful that there will be one more payment to RSA from the PFAS lawsuit that RSA is involved in.

With no further business to discuss, on a motion by Coppage, seconded by Marshall, the Board voted unanimously to adjourn at 2:21 p.m.







RAPIDAN SERVICE AUTHORITY SMALL PURCHASE PROCEDURES

By these procedures established and adopted by written resolution of the Board of Members, pursuant subsection G of Virginia Code § 2.2-4303 (Methods of procurement), Rapidan Service Authority may continue to purchase without requiring competitive sealed bids or competitive negotiation (i) professional services, (ii) goods and other services, and (iii) non-transportation-related construction, if the aggregate or the sum of all phases is not expected to exceed \$80,000, \$200,000, and \$300,000, respectively, while providing for competition wherever practicable, and otherwise complying with the Virginia Public Procurement Act.

Adopted by the Board of Members on November 20, 2025.

RESOLUTION

RESOLVED, that pursuant to Virginia Code § 2.2-4303 (Methods of procurement) under the Virginia Public Procurement Act, the Board of Members of Rapidan Service Authority, a public body as defined by § 2.2-4301 (Definitions), hereby adopts the attached "Small Purchase Procedures," and ratifies all purchases consistent therewith.

Re: 2025 Staff Retention Bonus

RSA Board,

From time to time, recommendations for employee bonuses have been brought forward. Given the ongoing challenges in recruiting and retaining qualified staff, I am recommending the issuance of bonus pay to our employees for the year 2025.

The total cost to RSA will not exceed \$26,000. Under this proposal:

- Full-time employees employed for more than half the year will receive a \$500 bonus.
- Part-time employees and Full-time employees who have been employed for less than half the year will receive a \$300 bonus.

I believe this initiative will support employee morale, strengthen retention efforts, and help us remain competitive in the current labor market.
