Rapidan Service Authority (RSA) is pleased to present to you this year's Annual Water Quality Report. This report is designed to inform you, the customer, about the water quality and services delivered to you every day. RSA's constant goal is to provide you with a safe and dependable supply of drinking water. We want you to understand the efforts we make to continually improve the water treatment process and protect our water resources. RSA is committed to ensuring the quality of your water.

The Madison raw water source is White Oak Run. The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity. Contaminants that may be present in source water include: (1) Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife. (2) Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming. (3) Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff, and residential uses. (4) Organic chemical contaminants, including synthetic and volatile organic chemicals, which are byproducts of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, and septic systems. (5) Radioactive contaminants, which can be naturally-occurring or be the result of oil and gas production and mining activities. In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. Food and Drug Administration regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

A source water assessment of White Oak Run was completed by the Virginia Department of Health in May 2002 and may be obtained by contacting Rapidan Service Authority. While the source water was determined to be highly susceptible to contamination using the criteria developed by the state, no known contamination was discovered during the period of review. The assessment report consists of maps showing the source water assessment areas and an inventory of known land use activities of concern.

Water is pumped from White Oak Run for conventional treatment that includes mixing, sedimentation and filtration. Chlorine is added to disinfect the water prior to its entering the distribution system.

RSA wants its valued customers to be informed about their water utility. If you want to learn more, please attend any of our regularly scheduled meetings. RSA routinely monitors for constituents in the drinking water according to Federal and State regulations. The following table shows the results of monitoring for the period **January 1 through December 31, 2017**. In this table you will find terms and abbreviations you might not be familiar with. To help you better understand these terms we've provided the following definitions:

- *Action Level (AL)*: the concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.
- *Maximum Contaminant Level (MCL)*: the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
- *Maximum Contaminant Level Goal (MCLG)*: the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
- *Maximum Residual Disinfectant Level Goal (MRDLG)*: the level of drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.
- *Maximum Residual Disinfectant Level (MRDL)*: the highest level of a disinfectant allowed in drinking water. There is no convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.
- *Nephelometric Turbidity Unit (NTU)*: a measure of the clarity of water. Turbidity in excess of 5 NTUs is just noticeable to the average person.
- *Non-Detects (ND)*: laboratory analysis indicates that the constituent is not present.
- *Parts per million (ppm) or milligrams per liter (mg/l)*: one part per million corresponds to one minute in two years or a single penny in \$10,000.
- *Parts per billion (ppb) or micrograms per liter (ug/l)*: one part per billion corresponds to one minute in 2,000 years, or a single penny in \$10,000,000.
- *Picocuries per liter (pCi/l)*: a measure of radioactivity.
- *Treatment Technique (TT)*: a required process intended to reduce the level of a contaminant in drinking water. Bracketed numbers represent the range of values detected.

We are pleased to inform you that we had no detections of total coliform bacteria in our water during calendar year 2017!

As you can see by the table, the Madison Water System had no violations for 2017. RSA is proud that your drinking water meets or exceeds all Federal and State requirements.

MCLs are set at very stringent levels. To understand the possible health effects described for many regulated constituents, a person would have to drink 2 liters of water every day at the MCL level for a lifetime to have a one-in-a-million chance of having the described health effect.

All drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk. Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Rapidan Service Authority is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested.
